 - Two walk in doors & two large overhead garage doors for access

 - Two walk-in doors & two large overhead garage doors for access

 - Four Large overhead garage doors for access

- _____ Other Areas – Show Arena, Horse Arena & Grass Areas
 - By permission, extra insurance requirements may be needed
 - GRANDSTAND AREA IS NOT INCLUDED ON FAIR RENTALS AT ANY TIME**
 - Proof of Insurance is required for all activities. Minimum Insurance needed is \$500,000.**
 - Keys will be issued when fees are paid - Deposit collected to save your date.
 - All buildings have electricity.
 - Security lights are available for evening activities.
 - There is NO access for a telephone for you to use.
 - Be sure you have a cell phone for emergencies
 - **No smoking** is permitted in enclosed buildings.
 - **No alcohol** may be sold on the fairgrounds except by fair society
 - No glass bottles
 - Fair society has a Beer permit. Contact us for specific needs.
 - You may provide free alcohol or guest may bring their own.
 - Insurance for your guests is your responsibility not the Fair grounds/Fair Society
 - Please Leave the Buildings and grounds clean like you found them.
 - This includes restrooms and kitchen
 - The trash is yours so please take it with you when you leave
 - Return all table and chairs where you found them
 - All Buildings and gates are to be closed when you leave
 - Deposits will be returned if everything is found in a neat, clean, and respectable condition with all above terms met.
 - If any extra cleaning needs to be done, lights or electrical units are left on, any damages found, or there are items missing, such will be deducted from deposits and/or you will be charged.
