Damage Deposit

A \$250 damage/clean up deposit is required to use the facility and is due one month prior to the event. This must be received as a separate check to be returned if everything is left in acceptable condition.

Established Non-profit groups ask for discount pricing.

* Full day rental is a maximum of 24 hours

* Half day rental is a maximum of 6 hours

One Half of the rental fee is due at time of booking. This is non-refundable. Other half is due one month prior to event.

Bar service Option

Is not included in rental rates

Bar service is available through the Floyd County Fair Society at a price of \$75 per bartender. The Floyd County Fair Society holds the approved license and insurance with the State of Iowa and the City of Charles City and Floyd County. No alcoholic beverages may be brought in from any other source. Beer, Wine and Liquor are available for purchase. Contact us for more information.

There will be no Alcohol Sales after Midnight

Proof of Insurance is required for all activities. Minimum Insurance needed is \$500,000.

- Keys will be issued when fees are paid - Deposit collected to save your date.
- Security lights are available for evening activities.
- There is NO access for a telephone for you to use. Be sure you have a cell phone for emergencies
- **No smoking** is permitted in enclosed buildings.
- **No alcohol** may be sold on the fairgrounds except by fair society

- No glass bottles
- Insurance for your guests is your responsibility not the Fair grounds/Fair Society
- Please Leave the Buildings and grounds clean like you found them.
- This includes restrooms and kitchen
- The trash is yours so please take it with you when you leave
- Return all table and chairs where you found them
- All Buildings and gates are to be closed when you leave
- Deposits will be returned if everything is found in a neat, clean, and respectable condition with all above terms met.
- If any extra cleaning needs to be done, lights or electrical units are left on, any damages found, or there are items missing, such will be deducted from deposits and/or you will be charged.
