- 1. Horse barn is in need of electrical upgrades and fans. Curt Brandau has estimates and he will discuss the estimates he has. Jim Roll Electric at \$4.3k and Stanton Electric \$3.1K were the two bid estimates. Jen Schmitt made a motion that the fair board to pay half of the cheapest estimate and the rest would be paid for by the horse people, Craig Anderson 2<sup>nd</sup>, motion passed.
- 2. Spring District meeting is Sunday, March 18<sup>th</sup> in Gladbrook, IA at 1 p.m. These five are responsible on going to one of the three held this year: Ben Kisch, Matt Ross, Tim Paplow, Ron Hillegas and Lyle Staudt. Kerry will contact and let them know that two will be there.
- **3.** With no carnival this year, how to use the camping spots up by the grounds. These are bigger spots and there were some complaints last year, wasn't enough space for slide outs. Lyle is going to consider a drop off day for campers so make sure people are parked in right spots and spaced correctly in there. It was discussed that fair board members and superintendents camp up in the camping area.
