- 4. Food stand/brick building combo update: 120X50 size fits in the discussed areas. Electrical bids are being submitted by Blake Jensen and Chuck Stanton currently. Plumbing and Heating by Mick Gage and the building itself by Morton and Countryside. Amy has a spec sheet for plumbing/heating and electrical, but does not have building info specs, just an outline drawing. Dennis suggested another contractor and was going to check for their bid. Until all bids come in we are using the \$400,000 mark which is a generic number according to size.
