

Floyd County Fair Board Meeting  
Zoom Meeting due to Covid-19  
April 15, 2020

Called to order at 6:01 PM.

Committee Reports:

4. Auction: Jerry Hegvedt will be taking over the auction free of charge, he would like to sponsor the auction, our cost will be minimal (postage, paper, printing) Lisa Sonberg and Leslie will work on catalog.
5. Building & Grounds: Well test came back good, do not have to shock this year. They are working at the flagpole at the grandstand. If locates are needed, Matt can do them over the internet.
6. Entertainment: Things are moving ahead, there are only a few acts that we may not get refunds on if we have to cancel due to the pandemic.
7. Endowment: None
8. Fund-Raising: Going to be slow this year due to pandemic. Show arena sponsorships have come in,
9. Publicity: Try to share the things on Facebook that have been shared.

1. Update from Bruce for district meeting, talked about state fair, state fair will be running cookie booth, moving big slide, every gate will have metal detectors, supreme 6 horse hitch will be free this year, Talking to your CPA in regards to taxes for youth if we were doing a ribbon auction (may need to consider this for live auction also) Palien and Ratopimiean state vet recommends no kill show because beef can carry it in their feces. Aug 30 in Wright County Seniors graduating if you are a fair board member and have a graduating senior there is a scholarship.
2. Little Hands building is up and they are working on plumbing and concrete. Valero said we are approved for the grant, but we don't know the exact amount yet. John Ruzicka is donating a bulk bin to use as a small grain bin for little hands on the farm. Amy is working on a rental contract for \$150 for 24 hours which would include the playground and picnic area. Amy will look into getting a fan in the building.
3. Livestock lean to should be started in the first week of May. We need to move the water hydrant that is in the courtyard. If the waterline is already there it would be good to just put a hydrant in the middle of the building at ground level.
4. Maintenance shed in the grandstand area has a huge drop and we need to put a retaining wall in that area. Amy meeting with Croell to try to get concrete blocks for this area.
